1. Introduction

The Economic Intelligence Unit (EIU) is pleased to present the **2025 Black Country Strategic Companies Barometer**, offering a comprehensive assessment of the largest and most economically significant companies operating across the sub-region. These companies are key to economic prosperity, contributing significantly towards employment and productivity and reinforcing the Black Country's position as one of the UK's core industrial centres.

This publication illustrates the scale of the contribution of strategic companies to the sub-regional economy. Supporting these firms to remain rooted in the area and to continue growing is essential for sustaining economic vitality and community wellbeing. At the same time, the analysis recognises that the local business base is predominantly composed of smaller enterprises, with only a very small proportion operating at a larger scale. Section 2 provides a brief overview of the overall business base, while Section 3 presents the main strategic company analysis, including breakdowns of value and diversity.

For the purposes of analysing strategic companies, The Data City has been used as it offers firm-level information that is not available through sources such as the ONS. Drawing on Companies House records and digital footprint analysis, the platform provides a more detailed view of business activities, emerging specialisms, and potential high-growth firms than conventional statistical sources can offer. However, several considerations are important when interpreting the outputs: coverage is shaped by the digital visibility of firms, modelled classifications may shift over time, and registered addresses do not always correspond to operational sites. The impact of these issues has been mitigated by triangulating data with official statistics and local intelligence, ensuring that analysis is robust.

2. Black Country Current Business Base

2.1 Turnover

- The Black Country is home to a diverse business base of **36,655 enterprises**¹ as of November 2025. An enterprise can be thought of as the overall business, made up of all the individual sites or workplaces. It is defined as the smallest combination of legal units (generally based on VAT and / or PAYE records) that has a certain degree of autonomy within an enterprise group (ONS, 2025).
- These firms have been categorised into five groups based on their turnover band in the year up to March 2025:
 - There are **1,210 “High Achiever”** companies in the Black Country - **these firms have a turnover of more than £5 million a year and account for 3.3% of the business base.**
 - **“Growth Pioneers”** are firms turning over **£1m-£4.99m** – **3,355** companies account for **9.2%** of the local business base.
 - The **8,930 “Potential Gazelles”** companies turning over £250k to £999k account for **24.4%** of the business base.
 - The **11,610** SMEs with a turnover between £100k to £249k are classified as **“Solid Performers”** and account for **31.7%** of the business base.
 - Firms turning over less than £100k are classed as **“Lifestylers”**, including micro enterprises, and there are **11,550** in the Black Country. This accounts for **31.5%** of the total business base.

Figure 1 - Black Country Business Base by Turnover Size Band



- Figure 2 shows the trend since 2014 in the number of enterprises in each turnover band. Each year there has been an increase in the number of enterprises **with a turnover of over £5m (High Achievers)** and in 2025 this reached **1,210**, an increase of 41.5% (+355 companies) from the 855 recorded in 2014.
- The Potential Gazelles group saw the largest growth in the number of companies since 2014 in percentage terms, at +58.1% (+3,280 companies) reaching 8,930 in 2025.
- The Solid Performers business group saw the largest growth in real terms, at +47.4% (+3,735 companies) reaching 11,610 in 2025.
- The data also reinforces the importance of smaller companies at the heart of the local economy, but the dip since the 2022 peak in Lifestylers, reaching 15,265 and down to 11,550 in 2025 suggests challenges in business survival.

Figure 2 – Black Country Number of Enterprises by Turnover Band



2.2 Employment

- 88.2% of enterprises employed between 0-9 people, which is slightly lower than the UK figure of 89.1%.
- Enterprises employing between 10-49 employees accounted for 9.7% of the Black Country base (UK: 8.8%).
- Medium-sized enterprises (50 - 249 employees) accounted for a larger proportion of Black Country businesses than the national average (1.7% vs 1.6%).

- There were 150 businesses with 250+ employees accounting for 0.4% of the Black Country base - equal to the national average.

3. Strategic Companies

The analysis in the following section is based on businesses that have been identified as a strategic company through The Data City platform. To be included in the analysis, a company must meet the following criteria:

- Turnover – minimum estimated turnover of £10m a year.
- Employees – minimum of 5 employees.
- Registered Address – company registered address must be in the Black Country (the four boroughs of Dudley, Sandwell, Walsall and Wolverhampton).

Through this process we have identified 450 companies that are included on the 2025 'Black Country Strategic Companies List'. Please see Appendix 1 for the full list of companies included in this analysis, their location, and sector. Figure 4 highlights the contribution of these companies to the Black Country Economy, this is explored further in the following sub-sections.

The analysis also considers the distribution of strategic companies across both the traditional Black Country sector framework and the Industrial Strategy 8 (IS8) sectors. Within the traditional framework, sectors are grouped into two categories:

1. The **transformational sectors** comprise those with the greatest potential to drive local economic growth through export activity, productivity improvements and supply chain development. These include **advanced manufacturing, building technologies, transport technologies, business services and environmental technologies**.
2. The **enabling sectors** play a critical role in supporting the wider economy and underpinning quality of life across the Black Country. Their performance influences the conditions required for growth within the transformational sectors. The enabling group includes **retail, the visitor economy, and health and wellbeing**.

3.1 Value to the Black Country Economy

- The strategic companies identified across the Black Country collectively generate an estimated **£14.1 billion in Gross Value Added (GVA)**, reflecting their substantial contribution to both the national and international economy.
- Several firms exceed **£500 million in GVA**, including DPD, Carlsberg Marston's Brewing Company (CMBC), One Stop Stores Ltd, and A.F. Blakemore & Son.
- JLR remains the most significant individual contributor, generating just over **£5 billion in GVA**.

- Given their scale, productivity and supply-chain reach, the continued presence and growth of these companies within the Black Country is critical to the performance of the sub-regional economy. Supporting their competitiveness and investment plans will be essential to narrowing the **£17.7 billion output gap** and strengthening long-term economic resilience.

- The **450 strategic companies** identified across the Black Country report a combined annual turnover of approximately **£58.8 billion**, underscoring their collective economic significance.
- The majority of firms operate at a smaller commercial scale, with **76%** recording estimated turnover below **£50 million**.
- At the upper end of the distribution, **2%** of companies generate turnover in excess of **£500 million**, highlighting the presence of a small number of large, market-leading enterprises alongside a broader base of mid-sized firms.

- Black Country strategic companies collectively employ **176,424 people worldwide**, reflecting their substantial labour market footprint.
- Around **25%** of these firms employ fewer than **50** people, while the majority (**55%**) fall within the **50–249 employee** range, indicating a strong concentration of medium-sized enterprises.
- A further **20%** employ **250 or more** staff, demonstrating the presence of several large employers with significant operational scale.


Figure 7 - Black Country Strategic Companies - Number of Employees

- **Advanced manufacturing** accounts for the largest share of strategic companies in the Black Country, representing **42%** of the identified cohort. This is followed by the **retail sector**, which comprises **24%**, and **business services**, accounting for **18%**.
- This distribution reflects the area's long-standing industrial base alongside a growing presence of service-oriented strategic firms.

- All of the Black Country's strategic companies are concentrated within a defined set of transformational and enabling sectors. **331 firms (74%)** operate within one of the **five transformational sectors**, with a further **119 companies (26%)** active in **enabling sectors**.
- Strategic companies within the transformational sectors generate the largest share of output, contributing **£11.54 billion**, or **82%** of total strategic company GVA.
- Within the transformational sectors, **advanced manufacturing** represents the most significant grouping, comprising **190 companies**. These firms generate **66%** of GVA within the transformational group and **54%** of GVA across all strategic companies, highlighting the scale and economic importance of manufacturing-led activity in the sub-region.
- Among the enabling sectors, **retail** is the dominant contributor, accounting for **92%** of firms and generating **95%** of enabling-sector GVA (equivalent to **17%** of total strategic company GVA). This reflects the presence of several major national retailers headquartered in the Black Country, alongside a wider base of regionally significant retail businesses.

- A total of **196 strategic companies (44%)** have a presence in at least one of the **Industrial Strategy 8 (IS8)** sectors. Collectively, these firms generate **£10.12 billion in turnover**, contribute **£2.99 billion in GVA**, and employ **45,477 people**, indicating their substantial role within the sub-regional economy.

- The **Professional and Business Services** IS8 sector accounts for the largest share of strategic company participation, representing **34%** of all firms, followed by **Advanced Manufacturing** at **10%**.
- Professional and Business Services is also the highest value-generating IS8 sector by a considerable margin, contributing nearly **£8 billion** in turnover and **£2.45 billion** in GVA, underscoring its importance to overall economic performance.



- The spatial distribution of strategic companies across the Black Country is relatively even. **Sandwell accommodates 30%** of all identified firms, followed by **Dudley with 27%**, **Walsall with 22%**, and **Wolverhampton with 21%**.


Figure 12 - Map of Black Country Strategic Companies

- Figure 13 shows that distinct sectoral concentrations are also evident, with the most prominent clusters observed in **Advanced Manufacturing**, **Retail**, and **Professional and Business Services**, reflecting long-standing industrial structures alongside the presence of major national and regional employers.

3.2 High Growth Companies

- A high growth company is defined, in line with the OECD methodology, as achieving an annualised average increase in turnover or employees of **20% or more over a three-year period**, with the company starting the 3-year period with at least 10 employees. On this basis, **14 strategic companies** across the Black Country meet the high-growth definition.
- These firms are distributed evenly across the sub-region, with the highest number located in **Walsall (6 companies)**, followed by **Dudley (3)**, **Wolverhampton (3)** and **Sandwell (2)**. Sectorally, the largest concentration of high-growth companies is found in **Building Technologies (5 companies)**, followed by **Advanced Manufacturing (4)**, **Retail (3)** and **Business Services (2)**.
- Collectively, the identified high-growth strategic companies employ **3,632 people** (around **2%** of all employment within the strategic company cohort), generate **£951 million** in turnover (**2% of the total**), and contribute **£411 million** in GVA (**3% of the strategic company total**). This illustrates that, while relatively small in number, high-growth firms make a meaningful contribution to economic output within the sub-region.



3.3 Founder / Director Demographics

- An assessment of the strategic company cohort indicates limited diversity among active founders and directors. Of the **134 businesses with identifiable active founders**, **104 (78%)** were solely-founded by a male, **10 (7%)** were solely founded by a female, **18 (13%)** were founded by a male-female duo, and **2 (1%)** are unknown.
- A similar pattern is evident at board level: of **1,701 strategic company directors where gender data is available**, **1,364 (80%)** are male and **337 (20%)** are female.
- Analysis of the **top 100 strategic companies by turnover** shows a broadly consistent distribution, reinforcing the overall trend of male-dominated leadership within the strategic business base.

Figure 15 - Gender Diversity of Directors



- Of the **3,300 strategic company directors for whom age data is available**, very few are under 35, with only **2 aged 16–24 (0.1%)** and **115 aged 25–34 (3%)**, indicating limited representation from younger leadership groups. Mid-career representation is higher, with **531 directors aged 35–44 (16%)**, although the overall profile remains weighted towards older cohorts.
- The largest concentrations are found in older age groups. Directors aged **45–54** represent **916 individuals (28%)**, while those aged **55–64** form the single largest cohort at **1,116 directors (34%)**.
- A further **407 directors (12%)** are aged 65–74, and **188 (6%)** are aged 75–84, with only small numbers continuing beyond this age. This distribution highlights a leadership base

dominated by mid- to late-career individuals, with relatively few younger directors entering senior roles.


Figure 16 - Age Group of Directors

- **Of the 3,292 strategic company directors for whom nationality data is available**, the overwhelming majority are British, with **3,004 individuals (91%)** identifying as British. This reflects a highly domestic leadership base with limited international representation across strategic companies.
- **Non-UK nationalities account for only a small share of directors**, with most individual nationalities representing **1% or less** of the total. The largest non-British groups include **American (43 directors)**, **French (35)**, **Irish (33)**, **Italian (22)**, **German (19)** and **Swedish (17)**, each comprising only a marginal proportion of overall leadership.

Figure 17 - Director Nationality - Top 10 Countries



3.4 International Ownership and Trade

- The majority of strategic companies are **ultimately owned by UK-based parent organisations**, with **236 firms** falling into this category.
- The **United States** represents the next most common source of ultimate ownership, accounting for **22 companies**, followed by a range of predominantly **European parent organisations**.
- The findings suggest that while domestic ownership remains dominant, international investment continues to play an important role within the business base.

Figure 18 - Ultimate Parent Company Nationality – Top 10 Countries



- Data from The Data City indicates that the Black Country has a significant cohort of **strategic companies** engaged in global trade, with **240 firms involved in import activity** and **218 in export activity**.
- Sandwell and Dudley account for the largest concentrations, reflecting their strong industrial footprints and established supply-chain networks. **Sandwell has 85 strategic companies that import and 78 exporters**, the highest in the sub-region, while **Dudley contains 72 import-active and 63 export-active strategic companies**. This distribution aligns closely with the area's wider manufacturing-led economic structure.
- Wolverhampton also has a sizeable group of internationally engaged strategic companies, with **51 importers and 47 exporters**, reinforcing its position as a key export hub within the Black Country economy.

- **Walsall**, while home to a smaller number of these firms (**32 importers and 30 exporters**), still contributes meaningfully to the region's trade activity, consistent with its strong manufacturing base.

JLR is a multibillion-pound automotive manufacturer owned by Tata Motors, with a major powertrain facility located at the i54 development on the Wolverhampton–South Staffordshire border. The site, formerly known as the Engine Manufacturing Centre, is transitioning into JLR's new Electric Propulsion Manufacturing Centre as part of the company's Reimagine strategy. Engine production is being phased out, and the facility will focus exclusively on manufacturing Electric Drive Units (EDUs) that will power JLR's future battery-electric vehicles, including the fully electric Jaguar brand from 2025 and the forthcoming Range Rover and Land Rover electric models. This shift marks the site's evolution from producing the Ingenium engine family toward becoming a core hub for JLR's global electrification plans.

The company combines Carlsberg's international brand portfolio with Marston's long-established British brewing heritage, overseeing production and distribution of leading beers such as Carlsberg, San Miguel, Poretti, Hobgoblin and Pedigree.

Wolverhampton serves as a strategic base for CMBC's corporate operations and wider national brewing network. Since its formation, CMBC has focused on modernising its brewing estate, strengthening supply chains and expanding its premium, world beer and alcohol-free ranges in response to changing consumer markets. The company remains a significant employer in the city, building on more than a century of local brewing heritage and supporting the continued growth of the food and drink manufacturing sector across the Black Country.
